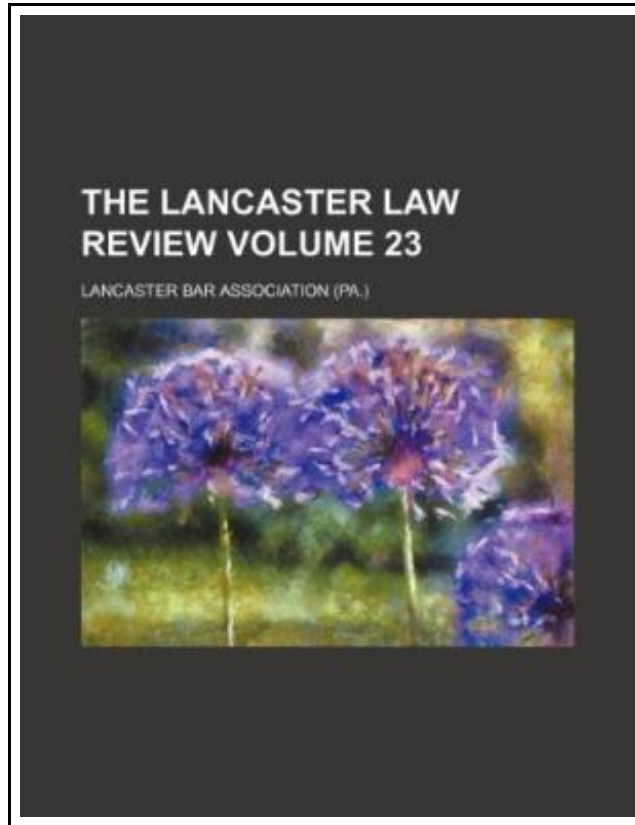

Not illustrated. 1906 Excerpt: . shall set forth that they verily believe the facts stated therein are true and correct to the best of their knowledge and belief, the allegation was undue or illegal and the return thereto not correct, and that the petition to contest the same is made in good faith. We think the petition does set forth the cause of complaint, showing wherein the allegation is undue or illegal, though wo do not in this proceeding pass upon the question as to how the three ballots described in the petition should have been counted by the election board, reserving that until the case is finally heard. In all other respects we find the petition complies with the Act of Assembly excepting as to the affidavit. The affidavit in the case simply states that the facts set forth in the foregoing petition are true and correct to the best of their knowledge and belief. This affidavit is not in the words of the Act of Assembly; and in Barnes case, 11 Phila., 881, Judge Mitchell held that the petition was defective if the affidavit was not as set forth in the Act of Assembly. The question, however, has since been passed upon by the Supreme Court. In Mook vs. Conrad, 155 Pa., 586, where they decided that if the affidavit to the petition avers that the statements of the petition are true to the best of the knowledge and belief of the affiants, it is sufficient.
